LEGAL SERVICES AGREEMENT

I authorize my attorney, **Fisher-Sandler**, **LLC**, to represent me in the following matters: **Uncontested Divorce**

My attorneys agree to professionally represent my interest to the best of their ability. I acknowledge that my attorneys cannot guarantee results and that my obligation to pay my attorneys their fees and costs is not contingent upon the results attained.

My attorneys shall be compensated at the following rates;

- (1) Fixed fee of \$777.00 for uncontested divorce, which shall include the filling fee and publication fee, if necessary. If service of process needs to be performed on the defendant spouse that would be an additional fee.
- (2) If a simple property settlement agreement is needed for a divorce filed on the grounds of a 6-month separation, it can be provided at no additional cost. However, if an Agreement is needed that would include detailed provisions on the division of assets or debts, or child custody or support provisions, the cost is an additional \$500.00. We do not do Qualified Domestic Relation Orders (QDRO).
- (3) We anticipate that your divorce will take about two months, or three months if notice is given by publication. This relies on you being responsive to our communication and getting forms signed quickly that we provide to you. If the client does not cooperate with counsel in moving his/her case forward in an expeditious manner, and as a result status conferences are scheduled by the court, the client shall pay an additional \$100.00 for each conference attended by counsel.
- (4) You are hiring us to do an uncontested divorce, and that means that you and your spouse both agree that you want to get divorced, and that your spouse will sign all necessary documents (waiver, final decree) to make this happen. You and your spouse signing all necessary forms mean we don't need to appear in court. If your spouse refuses to sign and we need to serve them and then appear in court, there is an additional \$300.00 fee.

I agree to provide my attorneys with a refundable retainer of \$777.00. I agree the minimum fee and retainer shall be provided in full at the time this Agreement is signed unless otherwise agreed. This money is refundable until my case is filed with the court. I understand that once my attorney has filed my divorce case with the court, the fee becomes non-refundable, even if I reconcile with my spouse or otherwise decide not to move forward with my case. I understand that I have hired my attorney to represent me for an uncontested divorce, and that if the case becomes contested, he will withdraw or non-suit, whichever is my preference, and that if this happens the fees paid are still non-refundable.

I agree that in the event my attorneys, at their election, turn my account over to collection, I shall be obliged to pay in addition to the balance of my account a collection or attorney's fee for the cost of collection in an amount of 25% of the amount then owed by me.

I have read this agreement and I understand it and agree to it. I acknowledge the receipt of a copy of this Legal Services Agreement.
